WATER RESOURCE MODELING

Accompanying the *Sussex County Open Space and Recreation Plan Update* are three *Technical Reports* which include the results of the detailed ArcGIS mapping analysis run to model water resources and prioritize land for preservation and stewardship. These reports are as follows:

- ✓ Technical Report I – Land Preservation (*Maps 1-13*)
- ✓ Technical Report II – Land Stewardship (*Maps A-I*)
- ✓ Technical Report III – Analysis and Recommendations (*Maps I-IV*)

Each report contains a table detailing the metrics, data, and mapping for the water resource areas studied in Sussex County. The final report includes a table detailing the priority lands for preservation, as identified by the water resource model in Sussex County. These are identified on a parcel basis and are ranked by their proximity to already preserved lands. This table, along with the accompanying mapping, provides the tools by which the County Open Space Committee, Board of Chosen Freeholders, and local officials can target their efforts to protect lands in Sussex County – focusing on those properties that support the water resources integral to the County and expand existing public open spaces.

Technical Report III – Analysis and Recommendations

The following maps identify targets for protection of the water resources in Sussex County. These maps are centered on the three focus areas: hydrology, stream and aquifer quality, and protecting aquatic ecosystem functions.

The first two maps (IA and IB) address Focus Area 1- Hydrology

Maps IIA and IIB address Focus Area 2, Stream and Aquifer Quality

The third set of maps, IIIA and IIIB map the five characteristics in the Aquatic Ecosystem Functions focus area.

The final set of maps (IVA and IVB) is a composite of all three focus areas. The maps exclude preserved lands from scored areas, and score the rest of the areas from 1-12.

Hydrology:

Map IA scores areas at priority levels 1 through 5. The map scores areas using a weight of 1 for each individual characteristic. Map IA shows areas which are ranked from those that have one of the characteristics present, to others where all characteristics are present.

Map IB further prioritizes these areas, separating them between high and low priority. Low priority areas are defined as areas with only 1 or 2 characteristics, where high priority areas have 3 to 5.

Stream and Aquifer Quality:

Map IIA scores different areas 1-4 depending on the number of stream and aquifer quality characteristics present.

Map IIB further prioritizes these areas, separating them between high and low priority. Low priority areas are defined as areas with only 1 or 2 characteristics, where high priority areas have 3 or 4.

Aquatic Ecosystem Functions:

Map IIIA scores different areas 1-4 depending on the number of the aquatic ecosystem function characteristics that are present.

Map IIIB further differentiates areas of high and low priority. Low priority is defined as those areas with 1 or 2 characteristics present, where high priority areas have 3 or 4.

Overall:

Map IVA ranges from scores 1-12, but the distribution is mapped in seven groupings, since virtually no areas scored 11 or 12. Again, the scores correlate to the number of present characteristics.

Map IVB splits the categories into high and low priority, 6-12 and 1-5 respectively.

Included within this report is the summary analysis of the merged mapping. There are several assumptions inherent in this review of the data:

- Preserved lands are excluded (state, federal, nonprofit land trust) – for land protection opportunities only those properties that are not already publicly owned were considered.
- Small parcels are to be excluded (less than 1.00 acres in size) – meaningful land preservation in Sussex County should focus on properties of a size to add value to the resource.
- Highlight those properties located within 500 feet of preserved lands – to identify those opportunities for expanded already protected corridors.

In summary:

There are 16,296 acres of non-preserved lands in Sussex County that are “high priority” per the water resource modeling analysis. Once all properties that are below 1.00 acres in size are removed, there are 14,776 acres potentially available for preservation. Screened further, those properties located within 500 feet of preserved land represents 9,959 acres of high priority lands in Sussex County, in 1,468 properties. Note, this is solely the acreage of the portion of the tax parcel that is identified as “high priority” for water resource protection. The total acreage of these 1,468 tax parcels is 52,159 acres.

The tables are useful, in part to show that many tax parcels have relatively small high priority areas as a percentage of the overall property, or in terms of total high priority acres. If they are important links for river corridors or other masses of high priority areas, then the parcel may

become a potential acquisition site, even though their total high priority area or percentage was low. On the other hand, if they are not important links, they may fall off the list.

There are many ways to review and use the water resource modeling results. These Technical Reports provide the basis and analysis for local decision makers and acquisition entities to assess groups of parcels within project areas and see what works. The composite maps with the seven groupings are a useful tool for this endeavor.

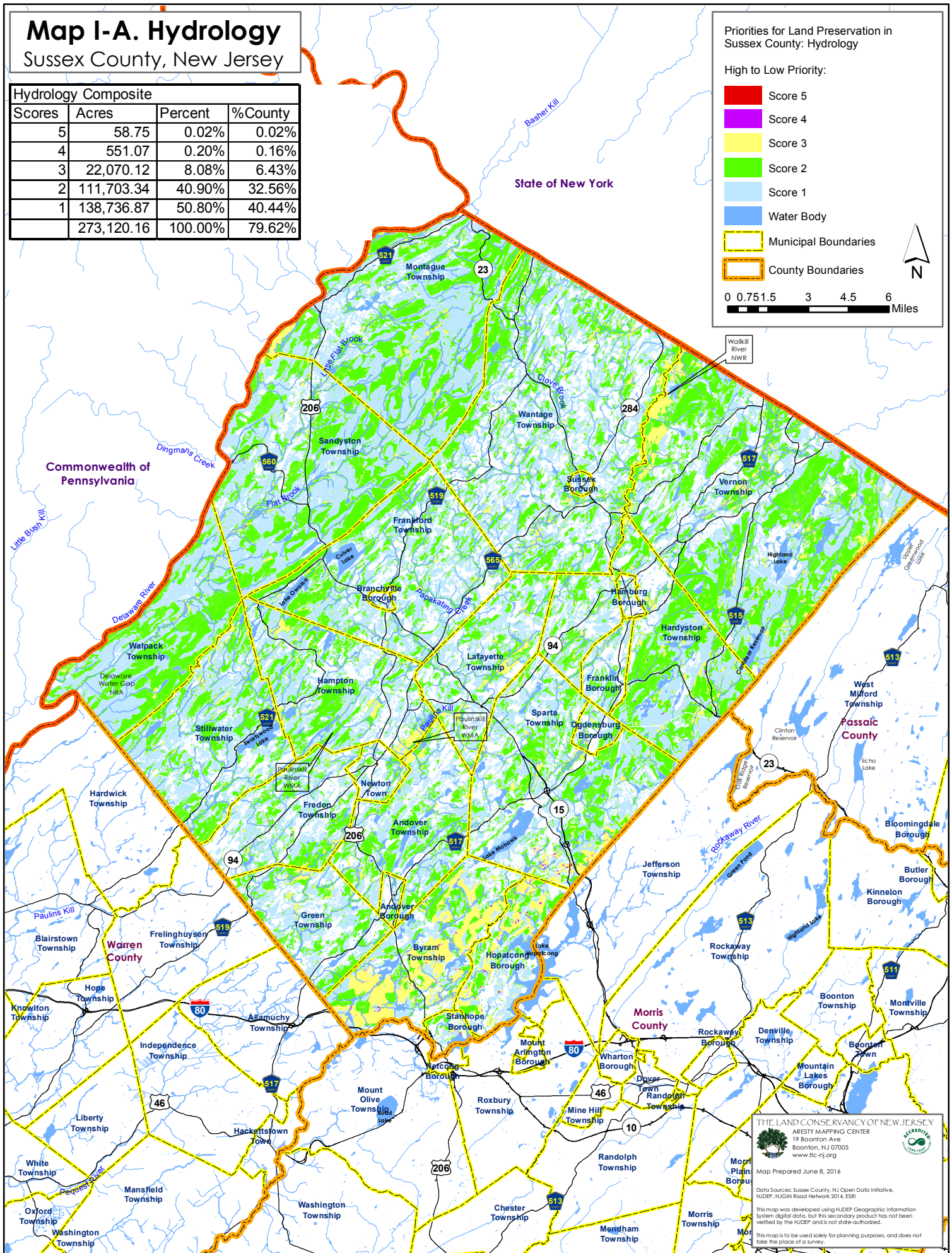

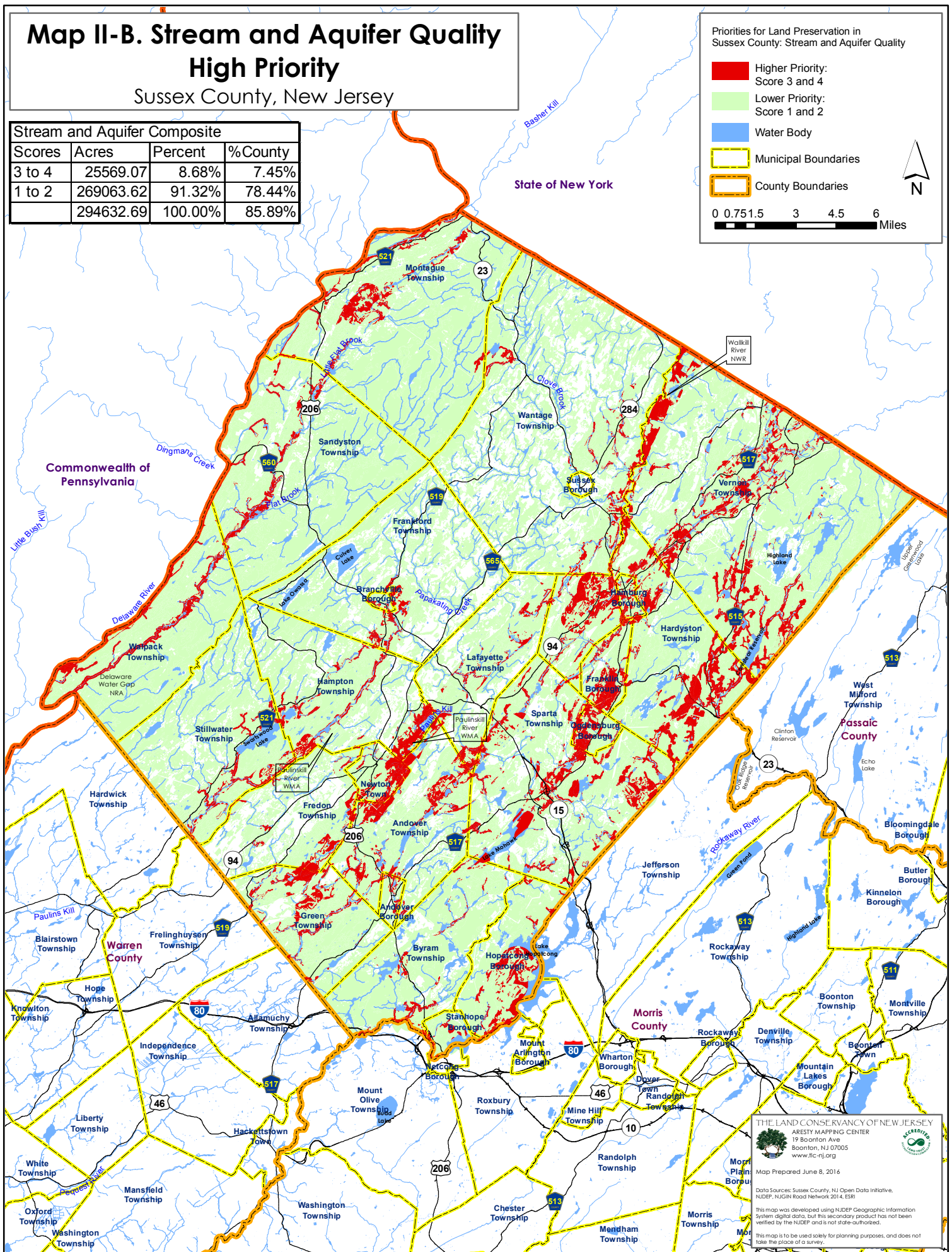

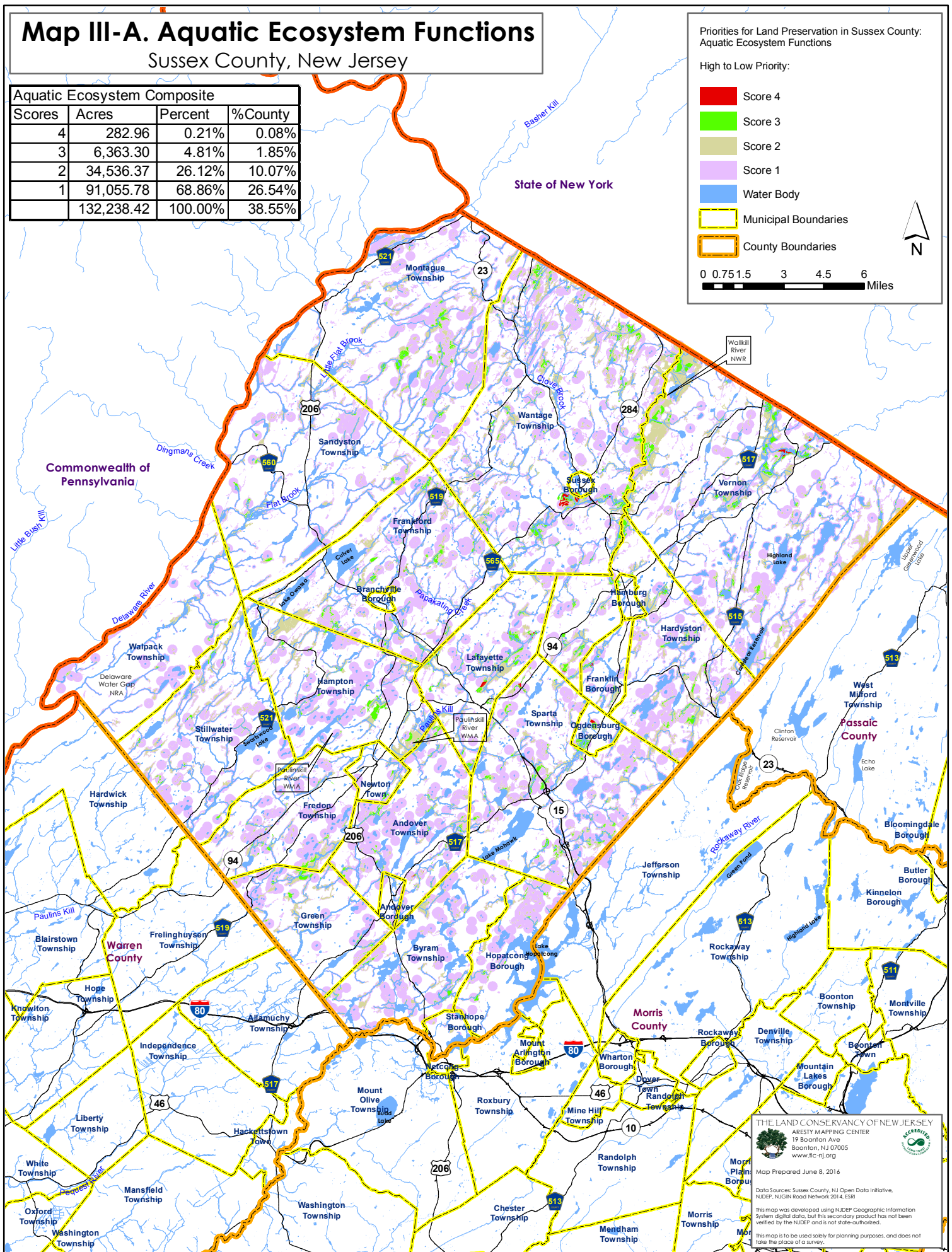

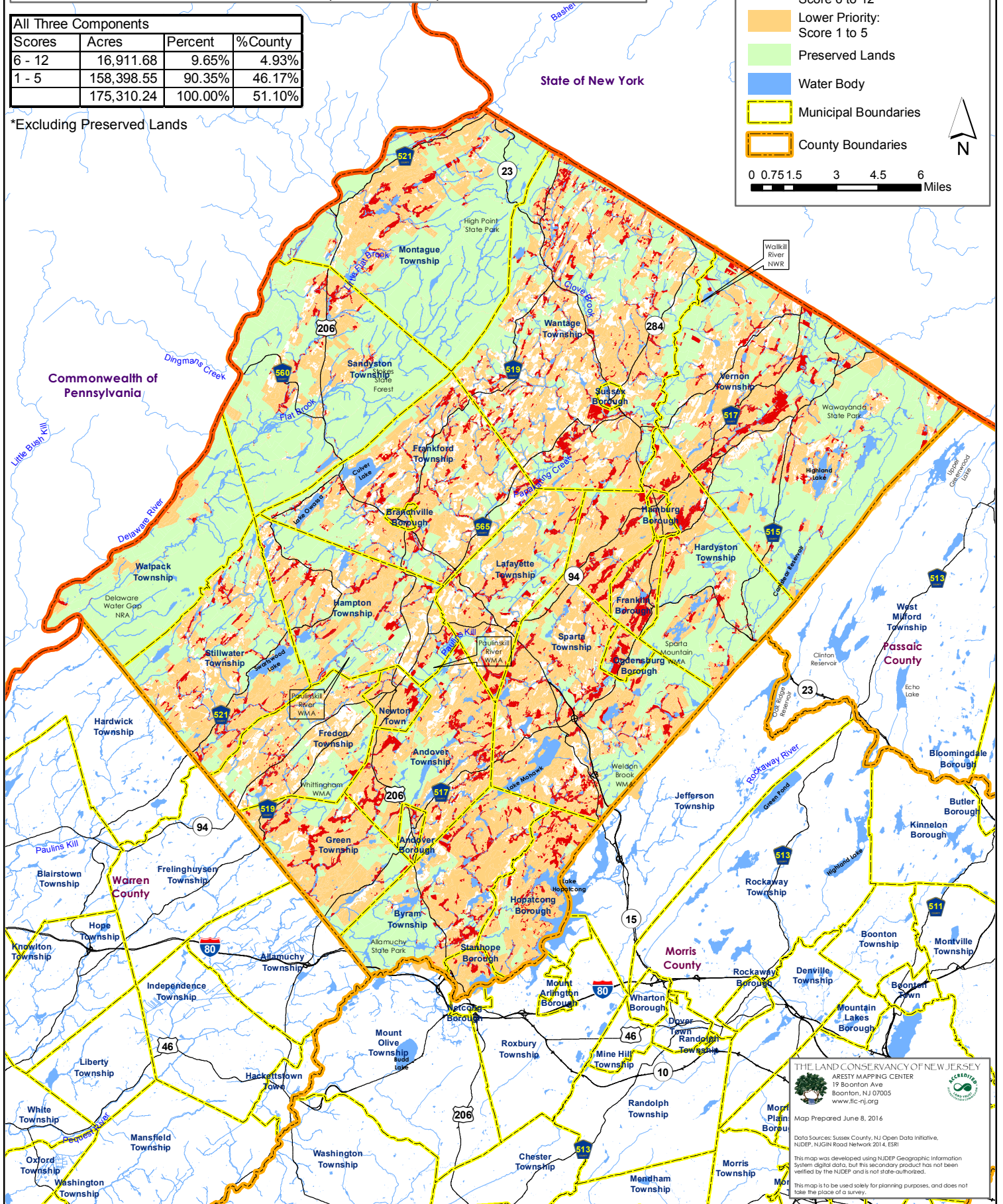
