RESOLUTION RE: AUTHORIZING PARTICIPATION OF SUSSEX COUNTY IN THE STATE DEVELOPMENT AND REDEVELOPMENT PLAN CROSS-ACCEPTANCE PROCESS

WHEREAS, the State Planning Act of 1985 (N.J.S.A 52.18A-196 et. seq.) created a State Planning Commission and an Office of Planning Advocacy for the purpose of establishing a cooperative planning process that involves the full participation of state, county and local governments; and,

WHEREAS, the State Planning Act states that New Jersey needs integrated and coordinated planning in order to conserve its natural resources, to revitalize its urban centers, to provide affordable housing and adequate public facilities at a reasonable cost, to promote equal social and economic opportunity for New Jersey's citizens, and to prevent sprawl and promote the suitable use of land, and,

WHEREAS, the primary duty and responsibility of the State Planning Commission under the State Planning Act is the preparation of a "State Development and Redevelopment Plan;" and

WHEREAS, the State Planning Act also provides that the State's counties are to have an essential role in the development of the State Plan through their participation in the Cross-acceptance process to be conducted under the Act; and,

WHEREAS, the Cross-acceptance process is the primary vehicle under the Act for promoting vertical coordination and integration of state, county and local plans by affording county and participating municipal governments a full and open opportunity to be involved in reconciling inconsistencies between state and local policies; and,

WHEREAS, the Sussex County Board of County Commissioners has concluded that it is appropriate, necessary and in the County's interest to participate in the development of the State Plan through the full and active participation of the County government, including in particular its Planning Board and its Division of Planning, in the Cross-acceptance process; and

WHEREAS, participation at this level and in this capacity will require refocusing existing staff within the Sussex County Division of Planning so as to provide for the effective and prudent administration and management of Sussex County's new role as the Negotiating Entity in the State Plan Cross-Acceptance process; and

WHEREAS, during this assignment the Division of Planning and Department of Engineering & Planning will strive to manage the overall Division workload in a prioritized manner and advance competing needs as efficiently as resources permit.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Sussex as follows:

- 1. That the Sussex County Division of Planning serve as the agent to the Sussex County Planning Board for performance of this assignment;
- 2. That the County Planning Board is hereby authorized and directed to carry out the Cross- acceptance process as the Negotiating Entity for County pursuant to the State Planning Act, N.J.S.A. 52:18A-196 et seq. and the State Planning Rules, N J A C. 15:30 and any other rules promulgated by the State Planning Commission for this purpose:
- 3. That the County Planning Board shall prepare a proposed work program and schedule for negotiating with represented county municipalities and county Cross-acceptance and shall submit said work program and schedule to the New Jersey Office of Planning Advocacy for performance of this assignment;
- 4 That the assignment will include prepare a Cross-acceptance Response Template and successfully complete the Cross-acceptance process as outlined in the 2024 Cross-Acceptance Manual prepared by the New Jersey Office of Planning Advocacy;
- 5. That all other County Departments and Agencies shall cooperate with the County Planning Board and Sussex County Division of Planning and provide information and furnish such documents as may be required.

BE IT FURTHER RESOLVED that the Commissioner Director and Clerk are hereby authorized to file application and execute any related agreement with the State Planning Commission for any financial assistance which may become available for the administration of the Cross-acceptance process and that their signature constitutes acceptance of the terms and conditions of the grant agreement and approves the execution of the grant agreement.
