RESOLUTION RE: AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF SNOW PLOW BLADES (RE-BID) FOR THE DIVISION OF PUBLIC WORKS, DEPARTMENT OF ENGINEERING AND PLANNING TO CHEMUNG SUPPLY CORPORATION, FROM SEPTEMBER 14, 2022 THROUGH SEPTEMBER 13, 2023

WHEREAS: public bids were originally advertised for the Supply and Delivery of Snow Plow Blades on June 30, 2022; and

WHEREAS: all bids were rejected pursuant to N.J.S.A. 40A:11-13.2(d); the contracting unit desired to substantially revise the specifications for goods or services; and

WHEREAS: public bids were advertised for the Supply and Delivery of Snow Plow Blades (Re-bid) on August 10, 2022; and

WHEREAS: the two (2) bids received have been reviewed by the Division of Public Works, Department of Engineering and the Purchasing Agent; and

WHEREAS: it was recommended by the Division of Public Works, Department of Engineering that an award be made to the lowest responsible bidder for the Supply and Delivery of Snow Plow Blades to Chemung Supply Corporation with all work performed under the Contract based on the services and the rates specified in the proposal; and

WHEREAS: the bidder has agreed to extend pricing as indicated in their bid proposal to other municipalities and governmental entities of Sussex County; and

WHEREAS: all work performed under this Contract shall have funds certified by the County Treasurer through an appropriately prepared and approved purchase requisition prior to the authorization of work to proceed.



BE IT FURTHER RESOLVED that the Director of County Commissioners, Clerk of the Board and their respective authorized designee(s) are hereby authorized and directed to execute a Contract and any related documents; and

BE IT FURTHER RESOLVED that this Contract will be in effect from September 14, 2022 through September 13, 2023 with the County reserving the right to extend said contract for one (1) additional and consecutive one (1) year period; and

BE IT FURTHER RESOLVED that a certified copy of this Resolution be forwarded to Chemung Supply Corporation, P.O. Box 527, Elmira, NY 14902.
