Public Notice - CR620 Glen Road- Gas Main Installation Project - Distributed: September 5, 2025

Project:

Installation of an 8", 4" & 2" EP PE Plastic Gas Main and residential gas services in and along Glen Road.

Locations are as follows:

- From the intersection of Arapaho Trail and Glen Road (CR 620), and ending at or near the Municipal Boundary of Sparta Township and Jefferson Township.

Contractor:

Penn Bower Inc., Contractors, on behalf of Elizabethtown Gas Company. (Note this work is being performed under a Sussex County Road Opening Permit for work within the County Right of Way).

Project Funding:

Private Funding.

Anticipated Schedule:

- Estimated Construction Start: On or about Sept. 15, 2025
 - Estimated Construction Completion: November, 2025
- (Schedule subject to change based on unforeseen conditions.)

Traffic Impacts:

Construction will require a single lane flagger controlled closure of CR-620. Expect Delays or Plan Alternate Routes. This project is to be completed during night time hours.

Construction Activities:

- Excavation and removal of materials to the depth of 36" to 42" in the northbound lane for approximately 19,020 LF.
- Place gas main within the trench area.
- Backfill trench with Dense Graded Aggregates compacted to a minimum of 95%.
- Place HMA asphalt mix (19M64) in various layers to the surface.
- Restripe in areas disturbed by limits of work as needed.
- Residential Gas Service installations.

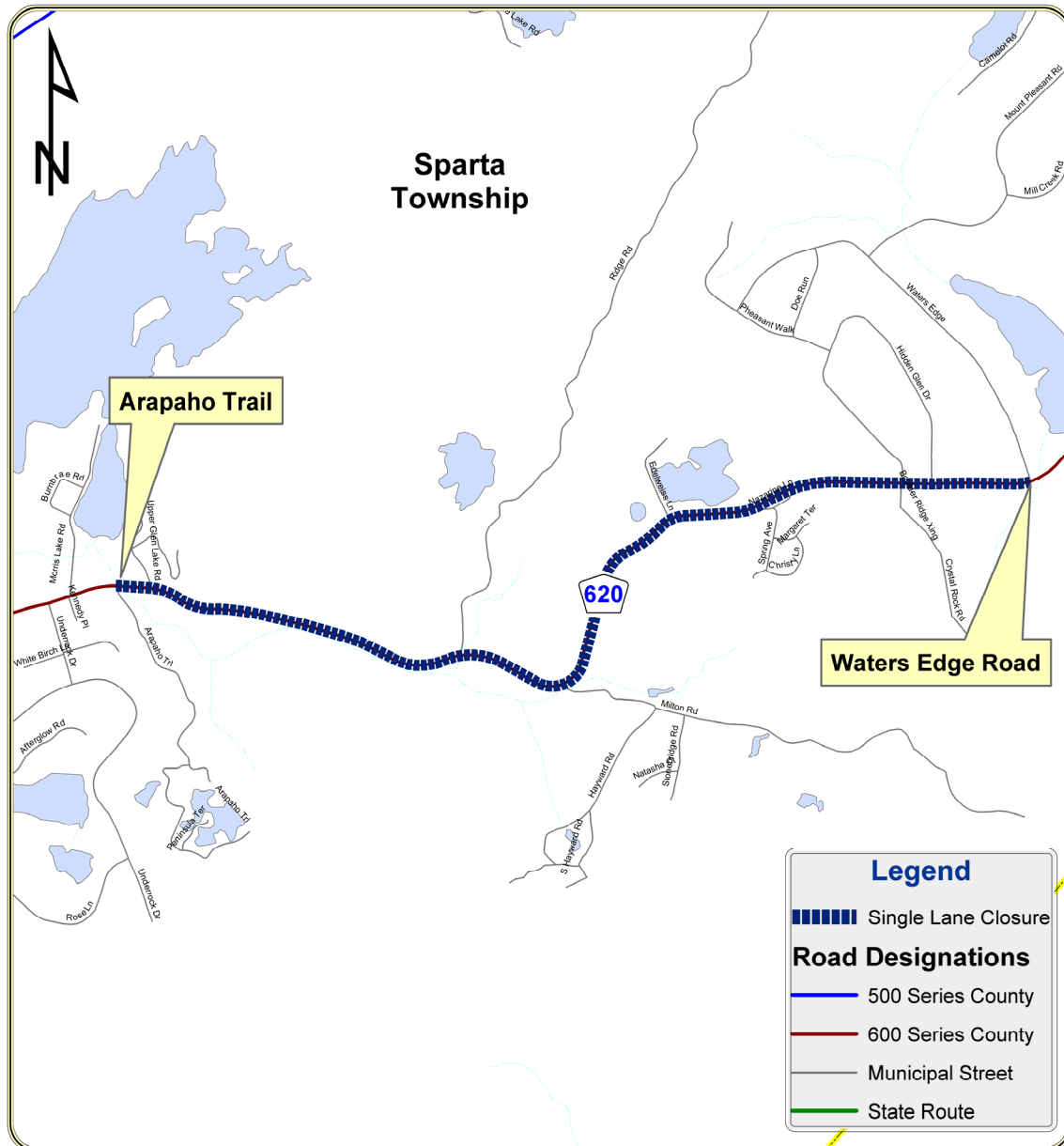

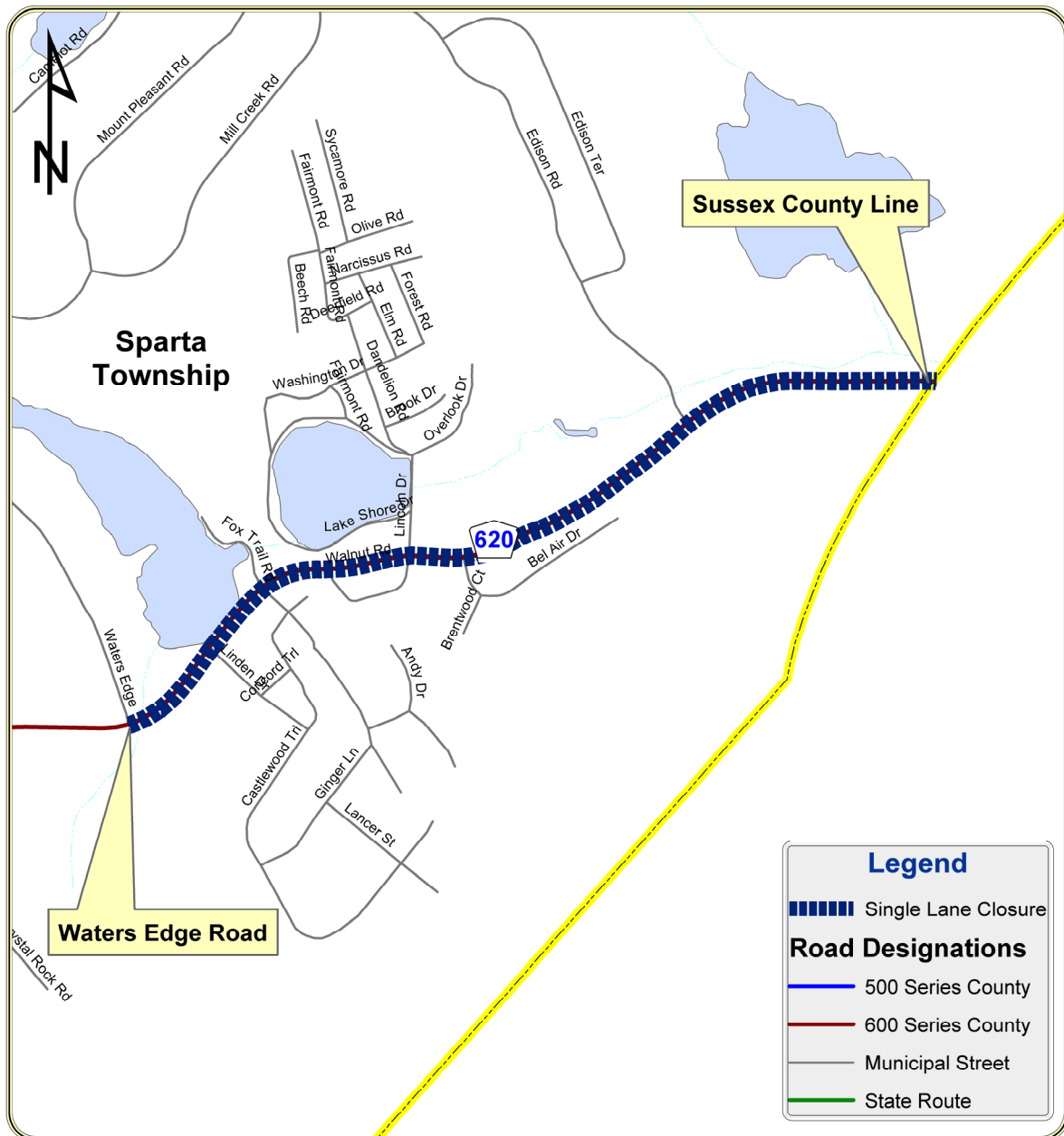
Map: CR-620 Glen Road – Project Limits
